TERMS & CONDITIONS

I understand that the Preview Membership provides an opportunity to explore the possibility of becoming a member of The Markers. I understand that, if I am accepted into the Preview Membership, there will be no initial Membership Deposit due.

If accepted into the Preview Membership, I agree to the following terms and conditions:

- I. COMMITMENT FOR A MINIMUM TERM OF MEMBERSHIP.** My Markers Preview Membership will begin when I am notified by the Club. The Markers Preview Membership will conclude after my six (6) or twelve (12) month Preview term concludes from the date I am approved, unless I choose to purchase a full Membership as described in Option 2. I understand that I am responsible for the payment of the Preview Membership Fee and any charges incurred during the term of my Markers Preview Membership.
- II. TERMINATION OF THE MARKERS PREVIEW MEMBERSHIP.** Nominee understands that he or she has no obligation to acquire a Membership. Nominee further understands that this Agreement is non-binding and does not convey a legal or equitable interest in the Club.

My Preview Membership shall terminate after my six (6) or twelve (12) month preview term concludes from the date I am approved unless prior to that date I have successfully completed the Club's membership process and have elected either of the following payment options:

OPTION 1: Within four (4) months of approval, I have paid the Membership Deposit stated for the Membership classification into which I have been admitted. Payment of the initial Membership Deposit may be paid either in full or in staged payments as represented below:

INDIVIDUAL MEMBER	\$285,000.00
(\$85,000 due no later than 4 months after Preview Membership approval, \$100,000 due within 6 months, and \$100,000 due within 8 months)	
PARTNER MEMBER	\$325,000.00
(\$85,000 due no later than 4 months after Preview Membership approval, \$120,000 due within 6 months, and \$120,000 due within 8 months)	

CORPORATE MEMBER

\$355,000.00

(\$95,000 due no later than 4 months after Preview Membership approval, \$140,000 due within 6 months, and \$140,000 due within 8 months)

OPTION 2: After my four (4) month anniversary but before my six (6) or twelve (12) month preview term concludes, I will pay the full Membership Deposit stated below for the Preview Membership classification into which I have been admitted. The full Membership Deposit must be paid on or before the last day of the twelfth (12) month of membership.
